MEMORANDUM OF UNDERSTANDING (MOU)

This "memorandum of Understanding " (MOU) is made on thebetween Vaishnav Mata Mahavidhyalaya Panna (M.P.) hereinafter termed as First Party and Nagar Palika Parishad Panna (M.P.) hereinafter termed as the Second Party. Second Party: Nagar Palika Parishad Panna runs with the goal and mandate to promote sanitation and hygiene in the area that falls under the jurisdiction of the Nagar Palika Parishad Panna

Aim/Purpose: The aim of This "MOU" is to provide a framework for co-operation between the two parties for safe collection and processing of solid wastes, e-wastes and chemicals generated in the Vaishnav Mata Mahavidhyalaya Panna (M.P.)

In this "MOU", the party hereto agrees as follows:

- The two parties shall work together in a cooperative and coordinated manner for the fulfilment of the purpose of the "MOU"
- The first party will collect the solid wastes, chemicals and garbages from specific points such as girl's hostel boy's hostel, science blocks, canteen and main gate every day in a week, except Sunday, between 10:00 am to 2.00 pm.
- The 2nd Party shall always keep the solid wastes and chemicals ready for the collection and disposal by the first party.

Validity: This "MOU" is valid till modified or terminated by any of the parties here above mentioned.

This parties acknowledge and agree that this "MOU" represents the entire agreement between the parties. In any circumstance that the parties desire to change any terms, they shall do it in writing and to be signed by both parties.
